**Re: Establishing a Los Angeles Embassy to Significant Religious Objects**

I write regarding your emails of 25<sup>th</sup> February and 19<sup>th</sup> March, in which you ask for letters of introduction to be forwarded to the Ministry of Defence, and for representations to be made to the Ministry of Defence to assist you in finding a suitable address to register a limited company.

Unfortunately, as I advised in my email of 12 February 2025, I am unable to act as a liaison between you and the Ministry of Defence in promoting businesses or performing introductions. You are able to contact Departments directly using the contact details available on their websites. It would be inappropriate for me, as a Member of Parliament, to seek to circumvent the official channels for business proposals.

With regards to your request that I contact the Ministry of Defence about finding a suitable address to register a limited company, I am afraid that again I am unable to assist you. The registration of companies does not sit within the purview of the Ministry of Defence. Advice on the information required by Companies House to register a limited company can be found at <https://www.gov.uk/limited-company-formation/company-address>. This advice is universal and I am unable to make representations for exemptions.

Finally, I note from your email of the 19<sup>th</sup> March, that you are now registered with the Job centre in Newquay. If your place of residence has changed please be aware that you will need to direct any future correspondence to the Member of Parliament for the constituency in which you are now usually resident. If you have not moved, and remain my constituent I would be happy to assist with anything that does lie within my remit as a Member of Parliament. However, I will not be able to respond to any further correspondence which relates to this project.
