Dear Chief Constable Nick Dean

**Ref: Establishing the Los Angeles Embassy to Significant Religious Object and Prince Edward**

This is my eighth letter intended for the Chief Constable of Cambridgeshire Police, the previous being sent by post in March requesting assistance in confirming that presentation intended for the Ministry of Defence had been received. This request arose following Huntingdon MP Ben Obese-Jecty declaring that he was unable to respond to any further correspondence related to *Establishing the Los Angeles Embassy to Significant Religious Object*. Following the May inauguration of Pope Leo XIV presentations *Battlestar Galactica & The Anti-Rockefeller Agenda* and *Jupiter Moon & Dismantling The Deep State* (restricted) have been updated for presentation to the House of Lords and are available for your review on enclosed USB pen drive folder <Establishing Los Angeles Embassy>, together with November 2025 presentations intended for:- (USB pen drive folder <Letters of Introduction November 2025>)

- Lord Malcolm Ian Sinclair Earl of Caithness

Initial presentation to the Ministry of Defence concluded with the statement:-

*'I wish to gift Range Rover KW03 VHX (in need of repairs) to the Corps of Royal Engineers as an introduction to asset management of BANCO ATLANTIDA and the development of inventory software in conjunction with the Brazilian Ministry of Defence.'*

The archaeological discoveries presented in dossier *Grail Technologies* (USB pen drive folder <Establishing Los Angeles Embassy>) are consequence of relocating to Brazil to further my own engineering career following the 1998 death of maternal grandfather Royal Engineer Lt. Colonel Lionel Dollery and then in 2005 my experiencing onset of the same muscle paralysis disease that took mother's life a resident of Brampton village in 2002. My professional engineering career having commenced in Yorkshire during 1994 with thanks to the Iranian Range Rover driver Dr Medy Zarrebini, November 2025 correspondence intended for the SNP and Chinese Government raise the issue of always honouring debts.

The British Government were first informed of Brazilian archaeological discoveries and supporting studios project during March 2009 as I made a lengthy statement at request of the Foreign Office to Florianopolis Federal Police Officer Chef Delegado Christiano Bath. Attempted update of that statement was denied by Chef Delegado Christiano Bath as I raised issue of Brazilian laws pertaining to national security during a pre-arranged appointment on the 22<sup>nd</sup> September 2010, Christiano Bath initiated abduction; consequential grievous bodily harm and a series of three incarcerations prior to deportation March 2012 (see statement - *Advocacy Preparation* - USB pen drive folder <Letters of Introduction/British Government>).

On the 24<sup>th</sup> November of this year I attended annual medical at Huntingdon Priory Fields Clinic and repeated presentation of document *Mental Health Review Request* (USB pen drive folder <Letters of Introduction/British Government/Cambridgeshire Mental Health>). I am in a state of logical belief that MI5 are aware of presentations pertaining to *Establish the Los Angeles Embassy to Significant Religious Object* and that the rhetoric being followed maybe the one instigated by my father (a pathological liar) – that of my life in Brazil was that of a deranged drug addict, suspected of international narcotic trafficking the studios project being for money laundering, hence the harsh treatment inflicted by Brazilian Federal Police.

Following delivery by hand of this presentation to Cambridgeshire Police HQ I intend to return to room 17 of Reef Lodge, 32 Island Crescent Newquay where I am currently staying as a guest under an extended stay agreement. I wish to withhold planned presentation to the SNP and governments of China and Jamaica believing that my persistency in presentation warrants a face to face appointment with either you, Ben Obese-Jecty or an MI5 Officer as a vetting for introduction to Prince Edward.
